Board Member Profile



We are pleased to introduce you to another one of our amazing board members, Mike Lester. Mike is the Director of the Colorado State Forest Service and has more than 30 years of professional experience in state and private forestry. Prior to being named Colorado state forester in 2013,

he served as assistant state forester for the Pennsylvania Bureau of Forestry. We met up with Mike recently to discuss the importance of our work here in Northern Colorado.

How do you see Peaks to People's work addressing the complex challenges facing our forested watersheds and the communities that depend on them?

There are several challenges that Peaks to People can impact in a positive way. First, given limited resources, we need to use science and data to focus our efforts on areas of the greatest need.

Second, given the magnitude of the job, no one entity can handle this by themselves. Peaks to People pulls together a partnership that is more powerful than its individual participants. Finally, Coloradans need to understand the importance of investing in their forests and Peak to People reinforces that for the citizens of Northern Colorado.


What benefits do you see our Watershed Investment Tool providing to public and private land managers?

The challenges to forest health can be overwhelming and the available resources underwhelming. The WIT allows us to apply limited resources where they will have the greatest impact on the health of our forests and the subsequent benefits to our watersheds.

How can Peaks to People Water Fund add value to forest restoration efforts already underway in Northern Colorado?

One of the most important contributions of healthy forests is enhancing the quality and quantity of water supplies. The Water Fund allows us to dedicate resources directly to the forests that will have the greatest impact on clean water

Resources for Landowners



Wildfire mitigation actions are on-the-ground treatments of forested properties implemented to reduce the threat of wildfire. These actions can take place before, during or after a wildfire has occurred. The Colorado State Forest Service (CSFS) is the lead state agency in fuels mitigation expertise in Colorado and an excellent resource for residents who

want to gain more information and take steps to decrease the threat of wildfire to their property.

A variety of programs for homeowners and landowners exist through the Colorado State Forest Service (CSFS) to assist them in managing their property. The Colorado State Forest Service helps individuals, landowners, community groups and others secure grants and assistance for projects that promote healthy and sustainable forest conditions in Colorado.

Programs Offered through CSFS

- **Forest Ag**
- **Forest Legacy Program** - The program authorizes the CSFS or U.S. Forest Service to purchase permanent conservation easements on private forestlands to prevent those lands from being converted to non-forest uses.
- **Forest Restoration & Wildfire Risk Mitigation Grant Program** - The FRWRM program was established through Senate Bill 17-050 and funded in 2018 by House Bill 18-1338 to provide state support in the form of competitive grant funds to encourage community-level actions across the state to:
 - Reduce the risk of wildfire to people, property, and infrastructure in the wildland-urban interface (WUI)
 - Promote forest health and forest restoration projects
 - Encourage utilization of woody material for traditional forest products and biomass energy
- **Forest Stewardship Program**
- **Homesite Assessments**
- **Tree Farm Program**

unique sources to proactively increase the pace and scale of forest restoration in the Big Thompson and Poudre River watersheds.


- Connect downstream beneficiaries and stewards (including landowners and others that are involved in natural resource management in the watersheds) to set strategic water supply protection goals.
- Obtain new and significantly scaled sources of funding for forest health treatments.
- Identify priority places for restoration and cost-effective risk reduction treatments.
- Create consistency in monitoring standards and measures of success.
- Track and report on the outcomes of forest health treatments in the watersheds.

Lory State Park

Important forest restoration work is continuing this summer in Lory State Park west of Fort Collins. Earlier this month three masticators were brought in for the start of the project. One started working along the hazard tree corridor with the other two working in the Soldier Canyon unit.

These projects aim to decrease hazardous fuels, increase forest health, reduce dwarf mistletoe, improve wildlife habitat, and increase forest resistance to insects, disease, and drought.
